What is the Mining and Petroleum Competence Board?

The Mining and Petroleum Competence Board (the Board) is a statutory board that advises the Minister (Deputy Premier) and the NSW Resources Regulator on:

- setting of competence standards
- standards for assessing competence
- requirements for the maintenance of competence for exercising functions at a mine that impact on the health and safety of any person.

The Board is established under the *Work Health and Safety (Mines and Petroleum Sites) Act 2013* (Act) and Work Health and Safety (Mines and Petroleum Sites) Regulation 2022 (Regulation).

The Board comprises people representing the interests of employers and employees, officers of the Department of Regional NSW and independents with expertise in the development and assessment of competence standards for people performing functions at mines. The Board is chaired by an independent chairperson.

Vision

The Board's vision is to improve mine safety by contributing to the development of world-leading competence standards in the NSW mining and petroleum industries.

Mission

The Board aims to ensure the competence of people performing safety critical roles in NSW mining operations, as part of an overall strategy to improve mine safety performance by:

- maintaining a strategic focus on significant competence issues
- undertaking consultation with all relevant stakeholders when progressing competence matters
- ensuring processes are put in place to quickly identify emerging issues and respond accordingly
- liaising with other jurisdictions, with an aim to promote consistency in competence standards
- ensuring that all key stakeholders have access to consistent and accurate information regarding competence standards.

The role of the Regulator

The Minister (Deputy Premier) and the NSW Resources Regulator, Department of Regional NSW, take advice from the Board on how to carry out their functions under the Act and the Regulation to:

- determine the requirements for certificates of competence and conduct examinations
- administer the issuing of certificates of competence and practising certificates, including requirements to maintain competence.

Introduction

The Board was established in 2014 following the introduction of the Act. The Board is subject to the control and direction of the Minister. Section 68 of the Act requires the Board to provide an annual report within six months of June 30 of its activities during the preceding year.

This is the Board's seventh annual report and covers activities between 1 July 2021 and 30 June 2022.

The Board met on four occasions during the year:

- 17 August 2021
- 16 November 2021
- 15 February 2022
- 10 May 2022.

As a result of COVID-19 restrictions, two of the four meetings were held via teleconference.

Functions of the board

The Board has the following functions under section 67(1) of the Act to:

- oversee the development of competence standards for people exercising functions at a mine that may impact on the health and safety of any person
- undertake initial and ongoing assessments of the competence of people exercising any such function
- advise the Minister on matters related to the competence required of people to exercise any such function.

The Board also has the following functions under section 170(1) of the Regulation to:

- advise the regulator on the training, qualifications, experience, knowledge or skills required for the exercise of statutory functions
- advise the regulator on the conduct of assessments, including the nature, type and manner of assessments
- make recommendations to the regulator in relation to conditions that may be imposed on a practising certificate
- ensure, as far as possible, that the competency required under this Regulation in respect of the
 exercise of a statutory function is consistent with the competency required in other Australian
 jurisdictions for the exercise of the statutory function
- recommend to the regulator requirements in relation to maintenance of competency for holders of practising certificates.

Terms of reference

The Board's terms of reference are to:

- oversee the development of competence standards
- oversee the assessment and examination process for the issuing of certificates of competence

- oversee requirements for the maintenance of competence
- provide advice to the Minister and regulator on matters related to competence requirements.

Identified priorities and vision

The Board has agreed on a vision to develop an efficient and effective scheme to ensure people carrying out statutory functions under work health and safety (WHS) laws are competent to carry out those roles to best practice WHS and engineering standards.

To achieve the vision, the Board identified the following priorities to 2023:

- 1. Monitor and review competence standards and assessment for statutory functions.
- 2. Monitoring and oversight of the maintenance of competence scheme.
- 3. Identify and address emerging issues for statutory functions.
- 4. Develop and implement a collaborative communication strategy.

Implementing actions in these priority areas will contribute to achieving the aim of the regulator for a safe and responsible mining, extractive and petroleum industry in NSW.

Activities of the Board in the preceding year

In line with the Board's endorsed Strategic Plan to 2023, the following activities were undertaken during the reporting period. The Board approved a work plan to support its Strategic Plan to 2023. The activities in the work plan are monitored by the Board on a quarterly basis.

1. Monitor and review competence standards and assessment for statutory functions

There are existing competence standards for statutory functions requiring certificates of competence.

Competence standards need to be monitored and revised in response to emerging issues to ensure safety standards are maintained. The Board advises the Resources Regulator on updating the competence standards for statutory functions requiring certificates of competence and the standards that should apply in the processes to assess applicants. This enables the competence standards for statutory functions to be up to date, relevant and world leading so people conducting these functions are competent and support safe mining operations.

1.1 Monitor the scheme while ensuring that it is aligned with other jurisdictions

To ensure consistency with other Australian states, two members of the Board plus the Chief Inspector of the Resources Regulator are members of the Australasian Mining Competence Advisory Council (AMCAC). AMCAC was established to ensure nationally consistent competencies for statutory positions in mining. AMCAC was established as part of the mine safety regulatory reform in the states of New South Wales, Queensland and Western Australia. Nil AMCAC meetings were held during the reporting period.

The Board monitors and influences Industry Reference Committees relating to the Resources and Infrastructure Training Package, under the Australian Industry Skills Committee. These committees are reviewing and updating units of competency for mining related qualifications.

1.2 Reform the assessment process

The assessment scheme for certificates of competence involves panels of people from industry and the mine safety regulator assessing the eligibility of applicants, including examining candidates through written and oral assessments. The scheme needs to remain efficient and effective so only suitable people receive a certificate of competence.

Certificate of competence examinations

Certificates of competence to exercise certain statutory functions are granted under the Work Health and Safety (Mines and Petroleum Sites) Regulation 2022. A person is eligible to hold a certificate of competence for a statutory function once they have been assessed and deemed competent to exercise that function.

Key requirements to determine competence for a certificate of competence include specified qualifications and experience, satisfying set criteria and an examination process. The assessment process is facilitated by the NSW Resources Regulator, with competence standards determined in consultation with the Mining and Petroleum Competence Board.

In response to an independent review conducted in 2019, review, a blueprint framework was developed and implemented, to standardise the way exams are constructed and delivered. The framework ensures validity, reliability, transparency and consistency of assessment.

During the reporting period, the Board endorsed changes to the assessment process. It was agreed that for candidates to be granted a certificate of competence they must be:

- assessed as competent for 100% of essential competencies and minimum 60% of desirable competencies in one round of exams for a function in a year,
- candidates who are assessed as competent for a minimum of 60% of essential and desirable competencies (or closest rounded down percentage) in their first attempt at the oral exam can re-sit in that round of exams.

Examiners and exam calendar

During the reporting period the Board endorsed the composition of examination panel members for the 2022/23 financial year. The Resources Regulator provides a calendar of planned exams annually to inform the Board. The calendar is available on the Resources Regulator's website.

1.3 Set and integrate specific requirements for emerging skillsets into standards and assessments

In reviewing the schemes for competency standards and assessment, emerging skills sets for statutory functions need to be identified and integrated into the competency standards. During the reporting period, the Board endorsed the following changes to practising certificates and certificates of competence.

Quarry manager certificate of competence

The Board endorsed the unit of competence RIIBLA401E Manage blasting operations (or equivalent superseded versions) as a pre-requisite for all new applicants for the quarry manager certificate of competence from the 2023 exams.

Quarry manager tier 2 practising certificate

The Board endorsed the gazettal for tier 2 quarry manager practising certificate requirements to be amended to add an eligible qualification for all tier 2 quarries (not specific locations):

- RII60220 Advanced Diploma of Extractive Industries Management, and any superseded equivalent version with the equivalent of RII60220 mandatory units completed, and
- Elective unit RIIBLA602E Establish and maintain explosives safety and security management systems to be completed as part of RII60220.
- upgrade from 'specific locations' to 'all tier 2 quarries' practising certificates, that other qualifications to those listed as eligible for a new certificate will be accepted if they are comparative.

Mining engineering manager certificate of competence

As part of the recommendations from the Queensland Coal Mining Board of Inquiry (Grosvenor Report), the Board agreed that RIIWHS601E competency (establishing and maintaining the WHS management system) should be a pre-requisite for applying for a mining engineering manager certificate of competence.

2. Monitoring and oversight of the maintenance of competence scheme

Practising certificates are required by people to exercise the statutory function prescribed in mine safety legislation. A key condition of a practising certificate is to maintain competence. The Board advises on the implementation of the scheme and performance of certificate holders in fulfilling their maintenance of competence obligations.

2.1 Board decision making is informed by evidence

The Board considers relevant information when making decisions. The Resources Regulator provides regular reports, policy position papers and analysis of reviews and inquiries to information the Board of competence and assessment matters.

2.2 Monitor and review the scheme auditing process

Practising certificate holders' compliance with maintenance of competence requirements are monitored by the Resources Regulator and the Board. The Resources Regulator provides reports on assessment outcomes for each Board meeting.

To ensure compliance, auditing is undertaken on an ongoing basis, starting with voluntary audits in years two and three of the scheme and progressing to random mandatory audits. Voluntary audits were not completed during the reporting period.

Core Mine Training and Mines Rescue were contracted to complete 100 audits of practising certificate holders for their compliance with the maintenance of competence condition by 30 June 2022. The Board will consider the outcomes of the audit at the first scheduled meeting of 2022/2023 financial year.

2.3. Proactive monitoring of performance indicators

The Board considers the effectiveness of maintenance of competence obligations on achieving the vision of a safe mining industry. The Board monitors indicators that report on practising certificate holders' awareness of their requirements and the effect of the scheme on safety, supervision, and the implementation of control measures.

The Resources Regulator quarterly safety reports and updates on the competence assessment scheme are tabled at each Board meeting. The Board monitors and identifies trends from these reports.

3. Identify and address emerging issues for statutory functions

The scheme for the statutory competency framework needs to be responsive to industry changes, as mine operators seek to be more productive and safer. These changes need to be identified and the impact on the competencies of statutory functions considered. This assists the Board in the early identification of emerging issues and advise on proactive steps to respond appropriately so people remain competent to the determined standards.

3.1 Monitor the mining industry for changes that may impact on the operation of the competency schemes for certificates

The Board draws upon its tripartite representation from across the mining industry to identify emerging trends affecting competency.

Impacts of COVID-19

The Board monitored the impacts of COVID-19 on examinations and maintenance of competence. During the reporting period, some examinations for certificates of competence were rescheduled due to COVID-19.

Resources and Infrastructure Industry training package

The Board and the Resources Regulator continued to be represented on the Coal Mining Industry Reference Committee for the Resources and Infrastructure Training package under the Australian Qualifications Framework (AQF). This involved input into various consultation processes to review and improve qualifications and units of competence impacting WHS, such as mine emergency response, and as pre-requisites for certificates of competence. These activities have supported improvements in the currency of competencies for mine workers.

Statutory Review of the *Work Health and Safety (Mines and Petroleum Sites) Act 2013* and Work Health and Safety (Mines and Petroleum Sites) Regulation

A report on the statutory review of the Work Health and Safety (Mines and Petroleum Sites) Act 2013 and Work Health and Safety (Mines and Petroleum Sites) Regulation 2014 (WHS (MPS) laws) was tabled in Parliament by the Deputy Premier on 10 November 2020. The review made 40 recommendations for improvements to the operation of the laws. Of the 40 recommendations, five were for action of the Resources Regulator in conjunction with the Board.

The Board considered whether:

The scope of the functions in Schedule 10 should be reviewed by the Mining and Petroleum Competence Board to ensure that there are no significant omissions or inflexibilities (recommendation 34 from the report).

The Board agreed:

- that no further statutory function positions are required
- the inclusion of a site senior executive (SSE) function is not considered necessary
- a statutory function of a Geotechnical Engineer is not warranted
- there is no need for a power system protection specialist and does not consider there is evidence to support this
- not to support the expansion of engineering manager roles
- there is not enough evidence to make the mine surveyor role a key statutory function
- that the function of Electrical Engineer be updated to include 'supervise and monitor' for consistency with the Mining Engineering Manager and Electrical Engineering Manager statutory functions, and the wording in the Electrical Engineering Control Plan Code of Practice be updated.

3.2. New modules are developed in response to emerging issues

Statutory functions require competent people to carry them out. As these competencies required change, there is a need to ensure people stay current. One way of ensuring currency of competencies is for maintenance of competence to underpin requirements for practising certificates.

Mechanical tradesperson statutory function

During the reporting period, the Board endorsed that the WHS (MPS) Regulation be amended to provide mine operators with the flexibility to identify appropriate qualifications, skills and experience in the mine's mechanical engineering control plan (MECP) which would be required in order to be nominated for the qualified mechanical tradesperson statutory functions.

4. Develop and implement a collaborative communication strategy

4.1 Develop key messages to be communicated

The Board reports on activities detailed in its Communications Plan at each meeting. The objective of the Communication Plan is to increase awareness within stakeholder groups and broader community about the activities of the Board. Sections 4.2 to 4.4 detail the activities completed during the reporting period.

4.2 Utilise a broad range of communication channels

To keep stakeholders informed of Board activities, the Board utilises a range of communication channels including:

- delivering presentations at stakeholder events
- participating in stakeholder forums including Australasian Mining Competence Advisory Council and Industry Reference Committees
- delivery of workshops
- publishing articles in the Mine Safety News
- publishing new and updated guidance material, board meeting agendas and minutes on the Resources Regulator's website.
