Control plan – ventilation control plan – acute exposure to irrespirable atmospheres

August 2024



The Resources Regulator has developed a broad-brush risk assessment and a program of bowties to review principal hazard and control plan topics.

The bowtie program identified the material unwanted events (MUE) and critical controls to prevent serious injury or death of mine workers.

The bowtie for the control plan topic of ventilation control plan identified one MUE and the critical controls for assessment programs. This fact sheet provides information related to the assessment program focusing on the MUE – acute exposure to irrespirable atmospheres

MUE critical controls

The Regulator's assessment program will focus on the following critical controls to prevent an acute exposure to irrespirable atmospheres:

- Mine design to manage contaminant generation and/or interaction with contaminants to within safe limits.
- Workers restricted/removed from areas with irrespirable atmospheres.
- Ventilation flow rates controlled to remove or minimise contaminants.
- Pre-drainage and gas drainage (irrespirable gas reduction).

Considerations

Mine operators should consider the MUE above as a minimum and ensure that the review of critical controls to prevent serious injury or death is included within the site ventilation control plan and associated documentation.
