

Activities at a glance

Summary of our regulatory activities in April 2021



Key activities

The NSW Resources Regulator published the following in response to four safety incidents of note.

- An <u>investigation release</u> relating to a worker who was injured by ejected components during an excavator bucket change-out at a quarry.
- A <u>safety alert</u> relating to a worker who sustained critical injuries after driving off the edge of a stope and falling 20 meters.
- A <u>safety bulletin</u> providing advice to industry in response to the increase in the number of reported explosives flyrock incidents involving damaged to equipment, infrastructure and exposed workers.
- A <u>safety bulletin</u> proving advice to industry resulting from two incidents where an explosionprotected diesel engine system (ExDES) failed to shut down upon initiation. The engines in both cases continued to run after the engine off switch was activated.

We also published a report on the <u>Review of serious injury and illness notifications</u> which identified a significant long-term downward trend in the serious injury frequency rate since 2006.

Stakeholder <u>comment</u> was also sought on proposed amendments to the *Work Health and Safety (Mines and Petroleum Sites) Act 2013* and Work Health and Safety (Mines and Petroleum Sites) Regulation 2014.

Two penalty notices totalling \$5,000 were issued to the titleholder of Exploration Licence EL 8967 for mining without an authorisation.

During commissioning the water line and filling with water, the end cap was removed to allow air to release from the system. A worker was removing the end cap when the cap shot off under pressure and travelled approximately 25 metres before hitting nearby infrastructure. The work was being conducted from an EWP about five metres from the ground at the time. Nobody was injured.
17 Apr	Coal mines	Fire and Explosion - Underground	Frictional ignition at the face when a miner intersected ironstone lens and ignited methane gas.
21 Apr	Coal mines	Loss of containment / control of pressurised fluid	While attempting to unblock a ballast borehole, a surface drill rig operator and assistant were peppered on the legs with ballast that ejected from the borehole. The operator was transported to hospital by helicopter and the assistant was driven to hospital.

28 Apr	Coal mines	Fire and Explosion - Surface	A fire occurred on an excavator. It appeared to have started on the rear engine and the fire suppression system was deployed automatically. The operator reported seeing flames via the onboard camera feed and then exited the excavator unharmed.
